

# Redding Rancheria Education Department: Johnson O'Malley 2026-27 Academic Incentive Application

**To qualify, ALL APPLICANTS (new and returning) MUST meet the criteria listed below.**

## Eligibility Requirements:

### 1. Applicants reside within the Redding Rancheria service area.

*The Redding Rancheria service area is defined as:*

- All of Trinity County,
- From the City of Redding to the Siskiyou County line,
- From the City of Redding to the Tehama County line (includes all Cottonwood addresses),
- From the City of Redding to Round Mountain (includes all Round Mountain addresses),
- From the City of Redding to Shingletown (includes all Shingletown addresses).

### 2. Children are 3-17 years old **AND** enrolled in Preschool through 12<sup>th</sup> grade.

*Preschool students MUST provide proof of enrollment in a curriculum based program - NO EXCEPTIONS.*

### 3. Children must be an enrolled member of a Federally Recognized Tribe **OR** be a descendant of an enrolled tribal member with at least ¼ blood quantum.

*Proof is required for EACH CHILD listed in the application.*

### 4. Submit required documentation:

- Most recent report card from the 26/27 School Year (Grades K-12).
- Enrollment verification for Fall 2026 (Preschool only).
- Native American verification (*Tribal ID, official letter, and/or birth certificates to link lineage*).
- Court-issued birth certificates (no hospital copies).
- Parent/Guardian's government-issued Photo ID.
- Legal guardianship paperwork, if applicable.

1. **Incentive Distribution Day:** Thursday, July 16<sup>th</sup> from 10am-1:00pm and Friday, July 24<sup>th</sup> from 10am-1:00pm at the RR Community Center.
